A regular meeting of the City Council of the City of Fayette met at 5:00 o'clock, p.m. on August 9, 2016, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Ray Nelson, Council members Linda McCraw, Mike Hardin, Jason Cowart, Cedric Wilson and David Brand. Also present were Police Chief Danny Jenkins, Fire Chief Tony Ellis, City Attorney Dale Lawrence, City Clerk Dawn Clapp and City Engineer Dewayne Roby.

The opening prayer was given by Mr. Bobby Avant.

Mayor Nelson announced that a quorum was present and the meeting was open for the transaction of business.

## APPROVAL OF MINUTES

Councilmember Wilson moved the minutes of the regular meeting held on July 26, 2016, be approved. Upon the motion being seconded by Councilmember McCraw, the same was unanimously approved.

### RECREATIONAL TRAILS GRANT

Mr. Terry Acuff reported the City's application was due for the Recreational Trails grant and the Council needed to adopt a resolution authorizing the submission of the grant application.

### RESOLUTION 2016-14

Mayor Nelson presented Resolution 2016-14 to the Council for their consideration. Resolution 2016-14 is as follows:

### **RESOLUTION 2016-14**

### A RESOLUTION AUTHORIZING THE MAYOR TO SUBMIT A GRANT APPLICATION TO THE STATE OF ALABAMA FOR RECREATIONAL TRAILS PROGRAM FUNDS TO PURCHASE THE ABANDONED NORFOLK SOUTHERN RAIL BED.

WHEREAS, the City of Fayette has been selected to submit a full application to the State of Alabama for Recreational Trails Program Funds to purchase the abandoned Norfolk Southern rail bed and construct a multipurpose – non motorized trail; and

WHEREAS, said programs are limited to funding a maximum of eighty percent (80%) of the proposed project cost which will be used to construct the trail.

NOW, THEREFORE, BE IT HEREBY RESOLVED, that the City of Fayette will commit twenty percent (\$25,000) of the proposed project cost for the purpose of matching the Recreational Trails Fund Project: and

BE IT FURTHER RESOLVED, that in the event the grant is awarded, the City of Fayette understands that it will sign assurances complying with all applicable Federal and State laws, rules and regulations.

#### AIR EVAC

Mr. LaTere Jones of Air Evac spoke to the Council. He said the Air Evac contract with the City covers all of the citizens of the City of they need to be air lifted from the City or Fayette County. It does not cover being airlifted from outside of Fayette County.

### POLICE DEPARTMENT REPORT

Police Chief Danny Jenkins presented the police report for the month of July 2016. The report for July was as follows: 35 incidents investigated; 13 accidents; 82 traffic citations; and 44 arrests.

She reported the  $\frac{1}{2}$ ¢ sales tax for the hospital generated \$35,212.00. She stated the City received \$10,122.00 in alcohol taxes. This was \$768.00 less than received last year.

The City Clerk stated the voting machines will be tested at the Civic Center on August 19.

The City Clerk also stated the City's Blue Cross and Blue Shield rates will stay the same.

### **AQUATIC CENTER REPORT**

Councilmember Brand stated thru August 8, 2016, the Aquatic Center had 27,714 in total paid attendance for the year. The daily average attendance was 380 which is 67 more per day than last year.
