A special meeting of the City Council of the City of Fayette, Alabama, was held at 12:00 o'clock, p.m. on August 30, 2016, pursuant to a call of the Mayor.

Upon roll call the following were found to be present: Mayor Ray Nelson, Council members Linda McCraw, Mike Hardin, Jason Cowart, Cedric Wilson and David Brand. Also present was City Clerk Dawn Clapp.

A Waiver of Notice of said special meeting which had been heretofore signed by each council member was ordered placed in the minutes at the end thereof.

The opening prayer was given by Mayor Ray Nelson.

The Mayor announced that a quorum was present and that the meeting was open for the transaction of business.

1. That Ray Nelson received a majority of the votes cast for the Office of Mayor and is hereby declared duly elected to the office for the term beginning on the first Monday in November, 2016.

2. That Eddy D. Campbell received a majority of the votes cast for the Office of Councilmember, Ward No. 2 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2016.

3. That Jerry Nichols received a majority of the votes cast for the Office of Councilmember, Ward No. 5 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2016.
