City Hall Fayette, Alabama June 26, 2018

A regular meeting of the City Council of the City of Fayette met at 5:00 o'clock, p.m. on June 26, 2018, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Ray Nelson, Councilmembers Linda McCraw, Eddy Campbell, Cedric Wilson and Jerry Nichols. Also present were City Clerk Dawn Clapp, City Engineer Dewayne Roby, City Attorney Dale Lawrence and Police Chief Danny Jenkins. Councilmember Jason Cowart was absent.

The opening prayer was given by City Engineer Dewayne Roby.

Mayor Ray Nelson announced a quorum was present and the meeting was open for the transaction of business.

APPROVAL OF MINUTES

Councilmember Wilson moved the minutes of the regular meeting held on June 12, 2018, and the special meeting held on June 14, 2018, be approved. Upon the motion being seconded by Councilmember Nichols, the same was unanimously approved.

EQUIPMENT REPAIR REQUEST

City Mechanic Curtis Moore reported on repairs the 1999 dump truck needed. He said it had less than 50,000 miles on it and its resale value was \$6,000.00 to \$10,000.00. He said the dump truck needed a new clutch assembly and transmission and the cost of these repairs would be \$4,567.00. He stated the dump truck was too small for carrying sufficient amounts of gravel or cold mix asphalt resulting in two trucks having to be used. He said the dump truck was also too small for pulling the trailer with the track hoe and this could present a safety issue. Mr. Moore said a used dump truck would cost \$65,000.00 to \$80,000.00. Councilmember Nichols requested City Engineer Dewayne Roby obtain some quotes on used dump trucks.

MAINTENANCE ASSISTANT POSITION UPDATE

Councilmember McCraw updated the Council on the maintenance assistant position. She reported there were five applicants for the position and they would be interviewed in the next couple of weeks.

FAYETTE 311 REPORT

City Engineer Dewayne Roby gave a report on the Fayette 311 system. He stated from October 1, 2017, until June 22, 2018, sixty requests were opened and of those fifty-six were closed.
