A regular meeting of the City Council of the City of Fayette met at 5:00 o'clock, p.m. on August 28, 2018, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Ray Nelson, Councilmembers Linda McCraw, Eddy Campbell and Jason Cowart. Also present were Police Chief Danny Jenkins, City Attorney Dale Lawrence, City Engineer Dewayne Roby and City Clerk Dawn Clapp. Councilmembers Cedric Wilson and Jerry Nichols were absent.

The opening prayer was given by Rev. Scott Smyth of Fayette First United Methodist Church.

Mayor Ray Nelson announced a quorum was present and the meeting was open for the transaction of business.

49TH ANNUAL ARTS FESTIVAL

Mrs. Anne Perry Uhlman reported the 49th Annual Arts Festival will be held on September 8th from 9:00 a.m. until 3:00 p.m. at Guthrie Smith Park. "Three on a String" will be the entertainment from 9:30 a.m. to Noon. The Fayette Arts Festival is the oldest running arts festival in Alabama.

Councilmember Cowart moved the minutes of the regular meeting held on August 14, 2018, be approved. Upon the motion being seconded by Councilmember McCraw, the same was unanimously approved.

1. FAYETTE MEDICAL CENTER

Mr. Jeff Huff, Interim Administrator of Fayette Medical Center along with Mr. Paul Betts, Chief Operating Officer of DCH, Ms. Mary Ann Harton, Assistant Administrator of Fayette Medical Center, Ms. Michelle Robertson, Director of the Nursing Home and Hospital Board members Mrs. Jackie Waldon, Mr. Owen Sweatt and Mrs. Sandy Nolen, appeared before the Council.

Mr. Jeff Huff and Mr. Paul Betts spoke to the Council concerning Fayette Medical Center. Both Mr. Huff and Mr. Betts thanked the Council for their financial support.

Mr. Huff reported for 2019-2020, there are \$2,000,000.00 in capital improvements planned for the Fayette Medical Center. He said these improvements would not be possible without the City's financial support. He asked the City to extend the ½ cent sales tax for the hospital.

Councilmember Cowart said since the City enacted the sales tax, rural hospitals have continued to close in Alabama. He said part of this is to be blamed on the State's stance on the Affordable Care Act. He said there are decisions that can be made at the State and Federal level that would take the burden off of city councils and county commissions in rural areas that are having to develop plans to try and keep their local hospitals open.

Probate Judge William Oswalt spoke and said he is thankful that he lives in a community where there is a consensus on the importance of healthcare and the importance of having a local hospital. He stated the community needs to continue to be proactive. He thanked the Council for their courage in implementing the additional sales tax.

Mrs. Jackie Waldon thanked the Council for their support of the hospital. She said the hospital is also seeking to attract more physicians to the community.
