- 2. That no candidate received a majority of the votes cast for the Office of Councilman, Ward No. 1 and that Virettia L. Whiteside and Steve Herring received the most and second most votes cast for that office, therefore a run-off election between said candidates is hereby ordered to be held on Tuesday, October 6, 2020, pursuant to the provision of Section 11-46-55, Code of Alabama, 1975, as last amended, and the Mayor is hereby authorized, directed and empowered to give notice of such run-off election in the form provided by law, including the persons authorized to vote therein, the place of voting and the same election officers who held the first election shall hold the run-off election. A copy of said notice was ordered to be placed in the minutes of the meeting.
- 3. That Eddy D. Campbell received a majority of the votes cast for the Office of Councilmember, Ward No. 2 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2020.
- 4. That Tommy Williams received a majority of the votes cast for the Office of Councilmember, Ward No. 3 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2020.
- 5. That Aliska Hughes-Monroe received a majority of the votes cast for the Office of Councilmember, Ward No. 4 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2020.
- 6. That Jerry Nichols received a majority of the votes cast for the Office of Councilmember, Ward No. 5 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2020.
