The Mayor and five (5) councilmembers who have been heretofore duly elected and certified as being elected to serve the City of Fayette, Alabama, for a period of four (4) years, from and after November 2, 2020, met at the Fayette Civic Center at Fayette, Alabama, at 6:00 o'clock, p.m. on November 2, 2020, for the purpose of organizing the council and the transaction of such other business that might come before the meeting. Also present were City Clerk Dawn Clapp and City Attorney Dale Lawrence.

ORGANIZATION OF COUNCIL

Honorable Rod Northam, Mayor-elect, acted as chairman of the meeting and called the meeting to order. Rev. Scott Davis offered the invocation.

The Chairman called upon Municipal Court Judge Steven Nolen, to administer the oath of office to the newly elected Council, whereupon the newly elected councilmembers were asked to come forward, they being Virettia L. Whiteside, Ward 1; Eddy Campbell, Ward 2; Tommy Williams, Ward 3; Aliska Hughes-Monroe, Ward 4; and, Jerry Nichols, Ward 5, whereupon Municipal Court Judge Steven Nolen, administered the oath of office.

The Chairman then called upon Municipal Court Judge Steven Nolen, to administer the oath of office to the newly elected Mayor, whereupon the Mayor and his wife, Mrs. Deana Northam, came forward and the oath of office was administered to Mr. Northam.
