City Hall Fayette, Alabama April 27, 2021

A regular meeting of the City Council of the City of Fayette met at 5:00 o'clock, p.m. on April 27, 2021, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Rod Northam, Councilmembers Virettia L. Whiteside, Eddy Campbell, Tommy Williams, Aliska Hughes-Monroe and Jerry Nichols. Also present were City Clerk Dawn Clapp, City Attorney Dale Lawrence and Police Chief Danny Jenkins.

The opening prayer was given by Bro. Scott Smyth, Pastor of Vision Church.

Mayor Rod Northam led the Pledge of Allegiance.

Mayor Rod Northam announced a quorum was present and the meeting was open for the transaction of business.

## **APPROVAL OF MINUTES**

Councilmember Nichols moved the minutes of the regular meeting held on April 13, 2021, be approved. Upon the motion being seconded by Councilmember Hughes-Monroe, it was unanimously approved.

Councilmember Campbell moved the minutes of the work session held on April 13, 2021, be approved. Upon the motion being seconded by Councilmember Hughes-Monroe, it was unanimously approved.

#### NORTHWEST ALABAMA ECONOMIC DEVELOPMENT ALLIANCE REPORT

Mr. Mark Brown, Chairman of the Northwest Alabama Economic Development Alliance, commonly known as C3, introduced to the Council Mr. Tom Wisemiller, the new President and CEO of the Northwest Alabama Economic Development Alliance. Mr. Wisemiller stated he had recently taken the position and was in the process of getting to know everyone. He is originally from Ohio, but spent twelve years in Greenville, North Carolina promoting and managing economic development projects.

### RESOLUTION 2021-04

Mayor Northam presented Resolution 2021-04 to the Council for their consideration. Resolution 2021-04 is as follows:

# **RESOLUTION 2021-04**

A RESOLUTION AUTHORIZING THE SUBMITTAL OF AN APPALACHIAN REGIONAL COMMISSION GRANT APPLICATION REQUESTING FISCAL YEAR 2021 ARC INITIATIVE POWER GRANT FUNDS WITH LOCAL MATCHING FUNDS OF THIRTY PERCENT

WHEREAS, City of Fayette, acting by and through its City Council proposes to apply for an Appalachian Regional Commission (ARC) Initiative Power Grant to construct improvements to the roof of the former Arvin Building which is now occupied by Phifer Wire.

THEREFORE, be it resolved by the City Council of Fayette, Alabama, as follow:

THAT, ROD NORTHAM, MAYOR, is hereby authorized to execute and submit an application with appropriate assurances to the Appalachian Regional Commission requesting Fiscal Year 2021 ARC Initiative Power Grant funds to construct improvements to the roof of the former Arvin Building; and

THAT, THE CITY OF FAYETTE will provide the required 30% of local matching funds required, which will be provided by Phifer Wire in support of this project.

Councilmember Nichols moved the Council adopt Resolution 2021-04. Upon the motion being seconded by Councilmember Whiteside, the same was unanimously adopted.

#### PARADE PERMIT

Mayor Northam presented to the Council a request for a parade permit for the March for Jesus to be held on May 15, 2021. Councilmember Whiteside moved the permit be granted. Upon the motion being seconded by Councilmember Hughes-Monroe, the same was unanimously approved

## FREEDOM FIBER EASEMENT FOR CONNECTION POINT AT OLD INDUSTRIAL PARK

Mayor Northam stated Freedom Fiber had requested the City consider granting them an easement at the old Industrial Park for a connection point for their fiber optic cable. The connection point would be similar to the one located at the Youth Center. Councilmember Campbell moved to proceed with granting an easement to Freedom Fiber for the connection point. Upon the motion being seconded by Councilmember Nichols, the same was unanimously approved.

## REPORT ON BUSINESS LICENSE

Mayor Northam reviewed with the Council the justification for moving the business license collections back in-house. He gave the Council the following report:

# Additional Business Licenses needed to offset increase = 110

Mayor Northam said the net difference between AVENU collecting the business licenses and the City collecting the business licenses is \$20,000.00. He said this could be offset by the City making sure every business in the City has a business license. He stated the Council would need to be ready to make a decision in June because the contract with AVENU expires in October. Councilmember Williams moved the Council proceed with having the City collect its own business license fees using City staff. Upon the motion being seconded by Councilmember Hughes-Monroe, the same was unanimously approved.

# **COVID-19 LEAVE POLICY REVIEW**

Mayor Northam reviewed with the Council the Covid-19 Leave Policy. Mayor Northam stated no employee is currently on Covid-19 leave. Councilmember Nichols stated he was in favor of rescinding the policy now. Councilmember Hughes-Monroe stated she was more comfortable leaving the policy in place until July. It was the consensus of the Council to continue the policy to the end of the original six month period, which would be the end of June.

#### RUBBISH CONTRACT WITH HARMONY LANE APARTMENTS

Mayor Northam presented to the Council for their consideration a rubbish contract between the City and Harmony Lane Apartments. The contract provides for the City to pick up rubbish at Harmony Lane Apartments once a week for a monthly fee of \$75.00. Councilmember Williams moved the Council authorize the Mayor, on behalf of the City, to enter into the contract with Harmony Lane Apts. Upon the motion being seconded by Councilmember Hughes-Monroe, the same was unanimously approved.

## RESOLUTION 2021-03

Mayor Northam presented Resolution 2021-03 to the Council for their consideration. Resolution 2021-03 is as follows:

### **RESOLUTION NO. 2021-03**
