City Hall Fayette, Alabama December 13, 2022

A regular meeting of the City Council of the City of Fayette met at 5:00 o'clock, p.m. on December 13, 2022, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Rod Northam, Councilmembers Virettia L. Whiteside, Eddy Campbell, Tommy Williams, Aliska Hughes-Monroe and Jerry Nichols. Also present were City Clerk Dawn Clapp, Police Chief Danny Jenkins, Fire Chief Shannon Taylor and City Attorney Dale Lawrence. Junior City Council Mayor Ben Olive was absent.

The opening prayer was given by Mr. Floyd Rodgers.

The Pledge of Allegiance was led by Mr. Floyd Rodgers.

Mayor Rod Northam announced a quorum was present and the meeting was open for the transaction of business.

APPROVAL OF MINUTES

Councilmember Campbell moved the minutes of the regular meeting held on November 22, 2022, be approved. Upon it being seconded by Councilmember Hughes-Monroe, it was unanimously approved.

TAP GRANT AGREEMENT FOR MLK DRIVE

Mr. Luke Porter spoke to the Council about the TAP grant for Martin Luther King, Jr., Drive. The grant is for \$1,000,000 with the City paying a 20% match. Mayor Northam presented Resolution 2022-21 for their consideration. Resolution 2022-21 is as follows:

RESOLUTION 2022-21

A RESOLUTION AUTHORIZING THE CITY TO ENTER INTO AN AGREEMENT WITH THE STATE OF ALABAMA FOR DOWNTOWN SIDEWALK IMPROVEMENTS

BE IT RESOLVED, by the City of Fayette as follows:

That the City enter into an agreement with the State of Alabama, acting by and through the Alabama Department of Transportation relating to a project for:

Downtown sidewalk improvements along 1st Ave. SW from 1st St. SE to Columbus St. E., along 1st St. SE from 1st Ave. SW to 1st Ave. SE and along 1st Ave. SE from 2nd St. SE to Columbus St. E; Project # TAPNU-TA23(912); CPMS Ref# 100076118 and 100075852.

Which agreement is before this Council, and that the agreement be executed in the name of the City, by the Mayor for and on its behalf and that it be attested by the City Clerk and the official seal of the City be affixed thereto.

BE IT FURTHER RESOLVED, that upon the completion of the execution of the agreement by all parties, that a copy of such agreement be kept on file by the City.

Mayor Northam stated the motion passed.

ACE UPDATE

ACE Coordinator Floyd Rodgers updated the Council on the ACE Program. Mr. Rodgers said they are working on a social media platform for the public to review information concerning the City. There are five committees currently at work: (1) Housing, (2) Leadership, (3) Transportation, (4) Tourism and (5) Annexation.

REQUEST FOR PURCHASE OF PIPE

Mayor Northam stated a sewer line needed to be replaced at the lagoon property. He stated the City needed to purchase 180 feet of four inch pipe at a cost of \$1,274.40. Councilmember Williams, moved the City purchase the pipe at a cost of \$1,274.40. Upon the motion being seconded by Councilmember Hughes-Monroe, the same was unanimously approved.

POLICE DEPARTMENT REPORT

Police Chief Danny Jenkins presented the police report for November 2022. The report was as follows: 36 incidents investigated; 19 accidents; 105 traffic citations; 95 traffic warnings and 30 arrests.

FIRE DEPARTMENT REPORT

Fire Chief Shannon Taylor presented the fire report for November 2022. The Fire Department received 18 calls.

STEP RAISE FOR TWO FIREFIGHTERS

Fire Chief Shannon Taylor requested a step raise for two firefighters – Firefighter Tyler Hayes and Firefighter Tyler Galloway. Councilmember Williams moved the Council approve step raises for Firefighter Tyler Hayes and Firefighter Tyler Galloway. Upon the motion being seconded by Councilmember Campbell, the same was unanimously approved.

HAZARD MITIGATION PLAN

Fire Chief Shannon Taylor stated in order for the City to be able to receive funds from FEMA due to an emergency and mitigation of the damage, the City must approve and adopt Fayette County's Hazard Mitigation Plan.

RESOLUTION 2022-20

Mayor Northam presented Resolution 2022-20 to the Council for their consideration. Resolution 2022-20 is as follows:

RESOLUTION 2022-20

A RESOLUTION ADOPTING THE 2020 FAYETTE COUNTY MULTI-HAZARD MITIGATION PLAN, IN FULFILLMENT OF THE FEDERAL DISASTER MITIGATION ACT OF 2000 AND THE LOCAL MITIGATION PLAN REQUIREMENTS OF 44 C.F.R. SECTION 201.6 AND FEMA LOCAL MULTI-HAZARD MITIGATION PLANNING GUIDANCE

WHEREAS, The Federal Disaster Mitigation Act of 2000 (DMA 2000), as administered by the Alabama Emergency Management Agency (AEMA) and the Federal Emergency Management Agency (FEMA) provides Federal assistance to local governments to alleviate suffering and damage from disasters, and broadens existing relief programs to encourage disaster preparedness plans and programs, coordination and responsiveness, insurance coverage, and hazard mitigation measures; and,

WHEREAS, the DMA 2000 requirements for local mitigation plans are set forth in 44 C.F.R. Section 201.6 and the Local Mitigation Planning Handbook, FEMA, March 2013; and,

WHEREAS, as a prerequisite for each Fayette County jurisdiction to continue to qualify for FEMA mitigation grant assistance programs, the DMA 2000 requires the five year update of the <u>Fayette County Hazard Mitigation Plan</u>, 2014 Plan Update, which was approved by FEMA on October 7, 2015; and,

WHEREAS, the AEMA had awarded a \$26,667.00 planning grant funded through the FEMA Hazard Mitigation Grant Program (HMGP) to the Fayette County Commission to fund 75% of the total costs of the five year plan update for all jurisdictions within Fayette County; and

WHEREAS, the 2020 Fayette County Multi-Hazard Mitigation Plan has been prepared in accordance with DMA 2000 requirements under the direction of the Fayette County Hazard Mitigation Planning Committee with the support of the Fayette County EMA, on behalf of all of the jurisdictions within Fayette County; and,

WHEREAS, said mitigation plan addresses all natural and man-made hazards deemed to threaten property and persons within the unincorporated and incorporated areas of Fayette County; and,

WHEREAS, the Federal planning criteria require formal adoption of the FEMA-approved plan

update by each participating jurisdiction.

NOW THEREFORE, BE IT RESOLVED that the 2020 Fayette County Multi-Hazard Mitigation Plan is hereby adopted and immediately made effective.

BE IT RESOLVED, by the City Council of the City of Fayette that it hereby awards the bid for resurfacing the tennis courts to the lowest responsible bidder, Hi-Tech Athletic Surfaces in the amount of \$36,000.00.
