City Hall Fayette, Alabama January 10, 2023

A regular meeting of the City Council of the City of Fayette met at 5:00 o'clock, p.m. on January 10, 2023, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Rod Northam, Councilmembers Virettia L. Whiteside, Eddy Campbell, Tommy Williams, Aliska Hughes-Monroe and Jerry Nichols. Also present were City Clerk Dawn Clapp, Police Chief Danny Jenkins, Fire Chief Shannon Taylor, Waste Water Superintendent Matt Buckner, City Attorney Dale Lawrence and Junior City Council Mayor Ben Olive.

The opening prayer was given by Rev. Jerry Bridges of Peaceful Rest Missionary Baptist Church.

The Pledge of Allegiance was led by Mayor Rod Northam.

Mayor Rod Northam announced a quorum was present and the meeting was open for the transaction of business.

PUBLIC HEARING FOR CLEAN WATER STATE REVOLVING FUND APPLICATION

Mr. Luke Porter of Porter-Higginbotham Engineering gave an overview of the City's CWSRF Wastewater Treatment Plant Project. He said the purpose of this project is to rehabilitate several of the functions of the City Wastewater Treatment Plant. He stated this project would address the immediate needs of the system as well as allowing the system to better handle upcoming demand. Mr. Porter said these improvements will directly benefit current customers while also allowing the City to meet the demands of future customers. He said the following repairs would be made:

- o Rehabilitation of the static screen
- o Rehabilitation of the solid's reactor
- Rehabilitation of the clarifiers
- o Replacement of 1 pump at the intermediate pump station
- o Replacement of 3 trickling filter recycle pumps
- o Replacement of 2 solids reactor recycle pumps
- o Replacement of chlorine contact chamber recycle pump
- o Replacement of aerator on aeration basin

Mr. Porter stated the City had applied for \$3,013,515.00 as a Clean Water State Revolving Fund (CWSRF) project. He said ADEM offered to fund the CWSRF project for the full amount of \$3,013,515.00. He stated \$1,000,000.00 would come through a ARPA 100% reimbursable grant. The remaining \$2,013,515.00 would be in the form of the SRF loan at an interest rate of 1.99% over 20 years.

Mayor Northam stated for the City to qualify for the grant and loan the City was required to raise its sewer rates. This was done by Ordinance 2022-04 which was adopted on August 9, 2022.

Questions were taken from citizens in attendance.

He said an event would be held at the Courthouse on January 16, 2023 at 10:00 a.m. and there would be a service at First Baptist Church of Fayette at 11:00 a.m. Rev. Bridges reviewed with the Council the agenda for the celebration.

Mayor Northam presented Resolution 2023-01 to the Council for their consideration. Resolution 2023-01 is as follows:

RESOLUTION 2023-01

A RESOLUTION AUTHORIZING THE CITY TO APPLY FOR A LOAN WITH THE ALABAMA WATER POLLUTION CONTROL AUTHORITY FOR THE CONSTRUCTION OF WASTEWATER TREATMENT/TRANSPORT FACILITIES

WHEREAS, the City of Fayette, herein called the "Applicant," after thorough consideration of the various aspects of the problem and study of available date, has hereby determined that the construction of certain works required for the treatment of wastewater and/or stormwater is desirable and in the public interest, and to that end it is necessary that action necessary for the construction of wastewater treatment and/or transport facilities be taken immediately; and

WHEREAS, under Code of Alabama 1975 §§ 22-34-1 et seq., and the regulations promulgated, thereunder in ADEM Administrative Code Chapter 335-11-1, the State of Alabama, has authorized the making of loans to aid in financing the cost of construction of necessary wastewater treatment and transport works to prevent the discharge of untreated or inadequately treated effluent into any waters;

NOW, THEREFORE, BE IT RESOLVED BY, the City of Fayette, the governing body of said Applicant, as follows:

THAT, the Mayor is hereby authorized to file in behalf of the Applicant an application for a loan to be made by the Alabama Water Pollution Control Authority;

THAT, the Mayor is hereby designated as the Authorized Representative of the Applicant for the purpose of furnishing to the Alabama Department of Environmental Management (ADEM) such information, data and documents pertaining to the application for a CWSRF loan from the Authority as may be required; and otherwise to act as Authorized Representative of the Applicant in connection with this application.

THAT, certified copies of this resolution be included as a part of the application to be submitted to the Department for a loan.
