A regular meeting of the City Council of the City of Fayette met at 5:00 o'clock p.m. on September 10, 2024, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Rod Northam, Councilmembers Virettia L. Whiteside, Eddy Campbell, Tommy Williams, Aliska Hughes-Monroe and Jerry Nichols. Also present were City Clerk Dawn Clapp, Police Chief Danny Jenkins, Fire Chief Shannon Taylor, City Attorney Dale Lawrence and Junior Mayor Sean White.

The opening prayer was given by Mr. Derek Porter.

The Pledge of Allegiance was led by Councilmember Eddy Campbell.

Mayor Northam announced a quorum was present and the meeting was open for the transaction of business.

# APPROVAL OF MINUTES

Councilmember Nichols moved the minutes of the regular meeting held on August 27, 2024, be approved. Upon it being seconded by Councilmember Whiteside it was unanimously approved.

#### PARADE PERMIT

Mayor Northam presented a request for a parade permit for the Frog Level Festival to be held on October 4<sup>th</sup> and October 5<sup>th</sup>. Councilmember Hughes-Monroe moved the Council grant the parade permit. Upon the motion being seconded by Councilmember Campbell, the same was unanimously approved.

### POLICE DEPARTMENT REPORT

Police Chief Danny Jenkins presented the police report for August 2024. The report was as follows: 32 incidents investigated; 12 accidents; 62 traffic citations; 44 traffic warnings and 44 arrests.

## STEP RAISES FOR POLICE DEPARTMENT

Mayor Northam said he had received a request from Police Chief Danny Jenkins to grant step pay increases for Lt. Michael Kelley from Lt. Step #7 to Lt. Step #8 and Corporals Trace Norris, Landon Miller and Jordan Roberts from Cpl. Step #3 to Cpl. Step #4. Councilmember Nichols moved to approve the step raises for Lt. Michael Kelley and Corporals Trace Norris, Landon Miller and Jordan Roberts. Upon the motion being seconded by Councilmember Williams, it was unanimously approved.

#### FIRE DEPARTMENT REPORT

Fire Chief Shannon Taylor presented the fire report for August 2024. The Fire Department received 19 calls.

## **RESOLUTION 2024-12**

Mayor Northam presented Resolution 2024-12 to the Council for their consideration. Resolution 2024-12 is as follows:

### **RESOLUTION 2024-12**

A RESOLUTION AUTHORIZING THE CITY OF FAYETTE TO MAKE AN APPLICATION FOR AIRPORT IMPROVEMENT FUNDING ASSISTANCE FROM THE STATE OF ALABAMA DEPARTMENT OF TRANSPORTATION AND THE FEDERAL AVIATION ADMINISTRATION TO MAKE IMPROVEMENTS AT THE RICHARD ARTHUR FIELD AIRPORT.

WHEREAS, the City of Fayette intends to apply for state and federal matching funds for airport improvement projects for the Richard Arthur Field Airport during fiscal year 2025.

THEREFORE, BE IT RESOLVED, by the City of Fayette as follows:

1. That the City of Fayette is authorized to make applications for airport improvement funding assistance from the State of Alabama Department of Transportation and the Federal Aviation Administration, for the purpose of undertaking projects in fiscal year 2025 to make improvements at the Richard Arthur Field Airport.

- 2. That the applications be submitted for and on behalf of the City of Fayette by its Mayor who is authorized by this resolution to sign the application and any related forms or documents on behalf of the city.
- 3. That the City of Fayette is authorized to enter into an airport improvement funding agreement with the State of Alabama, acting by and through the Alabama Department of Transportation, and the Federal Aviation Administration, for the purpose of undertaking projects to make improvements at the Richard Arthur Field Airport, with partial funding provided by the State of Alabama and the Federal Aviation Administration.
- 4. That the agreement be executed in the name of the City of Fayette for and on behalf of the City of Fayette by its Mayor.
- 5. That the authority of the City of Fayette to enter into contracts with the State of Alabama and the Federal Aviation Administration has been reviewed by the City's attorney, and in his/her opinion, the City of Fayette is duly authorized to commit the City of Fayette to agreements with the Alabama Department of Transportation and Federal Aviation Administration.

**BE IT FURTHER RESOLVED**, that the City of Fayette hereby affirms that the local matching share of funds in the amount required for this airport improvement project has been officially approved, placed into the budget of the airport and is available for expenditure upon execution of the Federal Aviation Administration's and the State of Alabama's funding agreements and the start of the project.
