City Hall Fayette, Alabama July 8, 2025

A regular meeting of the City Council of the City of Fayette met at 6:00 o'clock p.m. on July 8, 2025, in the Council Chambers of the City Hall.

Upon roll call the following were found to be present: Mayor Rod Northam, Councilmembers Steve Herring, Eddy Campbell, Tommy Williams, Aliska Hughes-Monroe and Jerry Nichols. Also present were City Clerk Dawn Clapp, Police Chief Danny Jenkins, Fire Chief Shannon Taylor and City Attorney Dale Lawrence.

The opening prayer was given by Chief Danny Jenkins.

The Pledge of Allegiance was led by Chief Danny Jenkins.

Mayor Northam announced a quorum was present and the meeting was open for the transaction of business.

APPROVAL OF MINUTES

Councilmember Nichols moved the minutes of the regular meeting held on June 24, 2025, be approved. Upon it being seconded by Councilmember Hughes-Monroe, it was unanimously approved.

POLICE DEPARTMENT REPORT

Police Chief Danny Jenkins presented the police report for June 2025. The report was as follows: 49 incidents investigated; 12 accidents; 68 traffic citations; 98 traffic warnings and 59 arrests.

CODE ENFORCEMENT OFFICER

Police Chief Jenkins presented the Council for their review a job description for a part time police officer to act as the code enforcement officer. No action was taken.

Fire Chief Shannon Taylor presented the fire report for June 2025. The Fire Department received 17 calls.

WHEREAS, the City of Fayette has received an Appalachian Regional Commission (ARC) Grant to construct water and sewer improvements to serve the Fayette Industrial Zone located along State Highway 171 in the southern section of the City of Fayette; and,

THEREFORE, in accordance with ARC regulations the City of Fayette and the Fayette Water Works Board have solicited and received bids from qualified construction companies to construct the above referenced water system improvements in accordance with the approved plans and specifications.

NOW, THEREFORE, be it resolved that the Fayette Water Board and McGiffert and Associates have evaluated the bids received and have determined that Morrow Water Technologies, Incorporated is the low bidder for the water system improvement phase of this project; and

THAT, Rod Northam, Mayor, be and is hereby authorized to award and enter a contract with Morrow Water Technologies, Incorporated in the amount of \$195,280.00 for the construction of the water system improvement phase of this project.
