- 2. That Cedric G. Wilson received a majority of the votes cast for the Office of Councilmember, Ward No. 4 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2025.
- 3. That Floyd Rodgers, Jr., received a majority of the votes cast for the Office of Councilmember, Ward No. 5 and is thereby declared duly elected to the office for the term beginning on the first Monday in November, 2025.
