A special meeting of the City Council of the City of Fayette, Alabama, was held at 12:00 o'clock, p.m. on September 30, 2025, pursuant to a call of the Mayor.

Upon roll call the following were found to be present: Mayor Rod Northam, Councilmembers Steve Herring, Tommy Williams and Aliska Hughes-Monroe. Also present were City Clerk Dawn Clapp and City Attorney Dale Lawrence. Councilmembers Jerry Nichols and Eddy Campbell were absent.

Mayor Northam announced a quorum was present and the meeting was open for the transaction of business.

CANVASS OF ELECTION RESULTS

The Council canvassed the election returns for the City Run-off Election held on September 23, 2025, and the result of the election is as set out in Resolution 2025-20. Resolution 2025-20 is as follows:

WHEREAS, the run-off election for the City of Fayette, Alabama, was duly and legally held on September 23, 2025, as provided by law; and,

WHEREAS, the municipal governing body of the City of Fayette, Alabama, met on this the 30<sup>th</sup> day of September, 2025, at 12:00 o'clock p.m., and has canvassed the returns, and has ascertained and determined the number of votes received by each candidate; and,

WHEREAS, the said municipal governing body has ascertained and determined the results of said election as follows:

Upon the motion being seconded by Councilmember Williams, the same was unanimously adopted.

There being no further business to come before the Council, upon the motion to adjourn being made by Councilmember Hughes-Monroe, and seconded by Councilmember Herring, the same was unanimously adopted.
